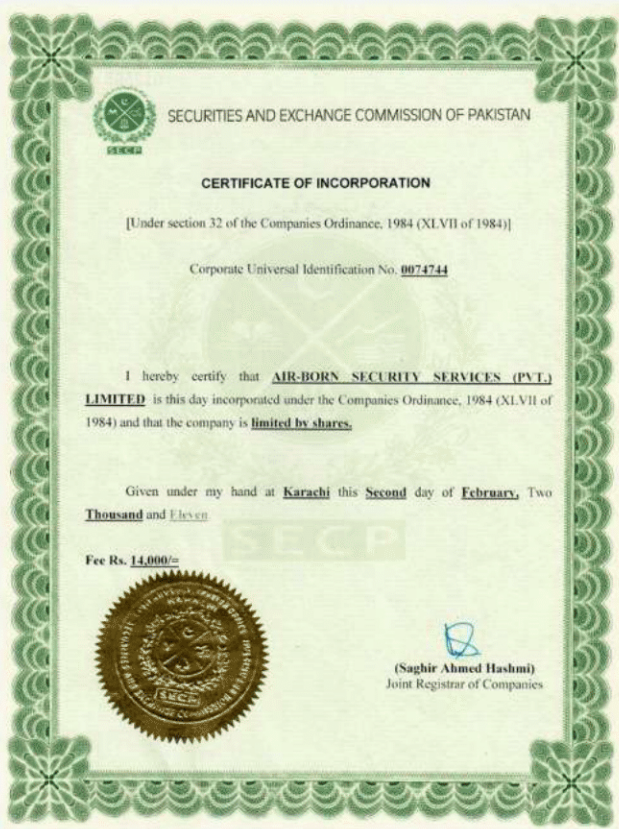

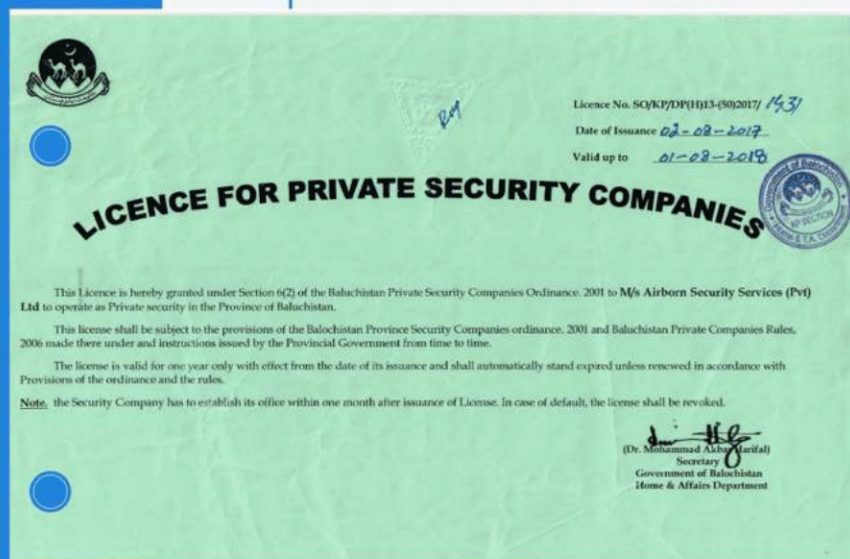

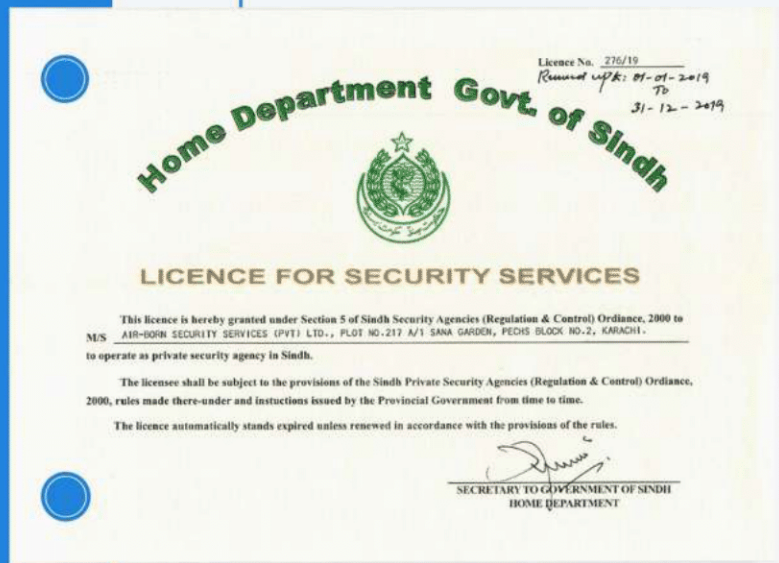

No. 21751/Home/2019 In exercise of the powers conferred upon him under Section

6(2) of the Private Security Companies Ordinance, 2001 and Rule 3(1) of Private Security Companies Rules, 2001, Chief Commissioner, ICT, has been pleased to grant license to **M/S Air Born Security Services (Pvt.) Ltd**, Plot No. 176, Main Korang Road, I-10/3, Islamabad, to operate as Private Security Company in Islamabad Capital Territory with immediate effect, subject to the following terms and conditions:-

- (i) The company shall abide by all legal and codal restrictions/instructions issued from time to time, for operating as security company including those as envisaged in the Private Security Companies Ordinance, 2001, the Rules framed there-under and the NOC issued by the Ministry of Interior.
- (ii) The company shall not include in any illegal activity / business and will not provide security for any illegal activity / business.
- (iii) The company shall abide by the instructions issued by the Ministry of Interior or the ICT Administration, from time to time.
- (iv) The company shall not include in any illegal activity / business and will not provide security for any illegal activity / business.
- (v) The company shall provide a list of employees on 1st of every month to the Sr. Superintendent of Police, Islamabad and AIG, Special Branch, Islamabad, for updating the record. No person shall be deployed for duty unless he has been cleared by the AIG of Police (Special Branch), Islamabad, or the district concerned. Company shall also furnish a security clearance certificate of all of its security guards, issued by the Police of the District concerned, to the licensing authority and Senior Superintendent of Police (Ops), ICT, Islamabad.
- (vi) The company shall send monthly report to the SSP (Ops), ICT, regarding functioning of the company and compliance of the laws/instructions applicable thereon.
- (vii) The company shall provide complete detail of the vehicles in use, to the SSP (Ops), ICT, Islamabad and also of all subsequent changes/replacements in this regard, in 1st week of every proceeding month.
- (viii) The company shall use the following pattern of uniform, duly approved by Ministry of Interior, for security guards, while performing duties:-
 - a. Trousers of Navy Blue colour without any piping.
 - b. Shirt Navy Blue colour with security badge on shoulders and a badge with insignia of the company, of black colour having the name of the company embroided on it in white colour on the left shoulder.
 - c. Brevet cap of black colour with a small size badge with insignia of the company embroided in white colour.
 - d. Belt black (leather or nylon) with rectangular steel buckle with insignia of company.
- (ix) The security guards shall display the badge or emblem as approved above. They shall also display their I.D. Cards containing company's name, their photographs issued by the company and the company shall have to deposit the specimens of the I.D. Cards to the ICT Police (Special Branch), Islamabad.
- (x) The security guards of the company must undergo training from one of the following designated approved training institutions, and no other institution is allowed to impart training to the guards of Private Security Companies:-
 - i. Fauji Foundation (Pvt.) Ltd.
 - ii. Askari Guards (Pvt.) Ltd.
 - iii. National Police Foundation (Pvt.) Ltd.
 - iv. Police Training School, Police Line, H-11, Islamabad.
- (xi) The Private Security Company shall abide by all relevant laws/rules applicable thereon.
- (xii) The security company shall furnish a complete kit of uniforms to the Office of Inspector General of Police, ICT, as a specimen.

-: 2 :-

- (xiii) The security company shall not allow any person other than the security guards to travel in vehicles of the security company.
- (xiv) The security company shall in no way exercise or appear to exercise authority in excess of that allowed by the law to the citizens.
- (xv) The office of the security company shall be opened to the periodic inspection by the Senior Superintendent of Police, ICT, or any Police Officer authorized by him as well as the Deputy Commissioner or any officer authorized by him.
- (xvi) The security company shall provide a wireless set to the Islamabad Police for communication purpose.
- (xvii) The security company shall abide by its undertaking that the management shall not transfer/hand over/sub-let the company to any other person/partly in any form.
- (xviii) The security company is not authorized to execute contract or sell this company to any Foreign Security Company/Group of Companies or Foreign person.
- (xix) The security company shall maintain a safekeeping room for safe custody of weapons.
- (xx) The security company is not allowed to render its services to the Key Points of the Government. The security company is not authorized to provide security services to any Provincial Government / Federal Government or any body/organization or agency of such Government.
- (xxi) The license of the security company is valid for One Year from the date of issue and is renewable on annual basis. The security company shall apply for renewal of license one month prior to its expiry alongwith renewal fee of Rs.5,000/- in the shape of bank challan, or the fee revised from time to time, failing which the license shall be suspended in addition to any other action under any law applicable thereto.
- (xxii) The license of **M/S Air Born Security Services (Pvt.) Ltd**, shall be cancelled if its performance is found unsatisfactory or the violation of any term & condition of the license, is committed or its employee is found engaged in the activities prejudicial to the interests of the State.
- (xxiii) The security company shall ensure to get it registered with Employees Old-Age Benefit Institute (EOBI), Government of Pakistan, Islamabad and ICT Employees Social Security Institute (JESSI), Islamabad within one year of the issue of this license and prior to apply for renewal of license and shall submit the registration certificates to this office.
- (xxiv) Security guards should be physically fit and security company shall provide medical certificate of security guards to the licensing authority as well as to special Branch, Islamabad.

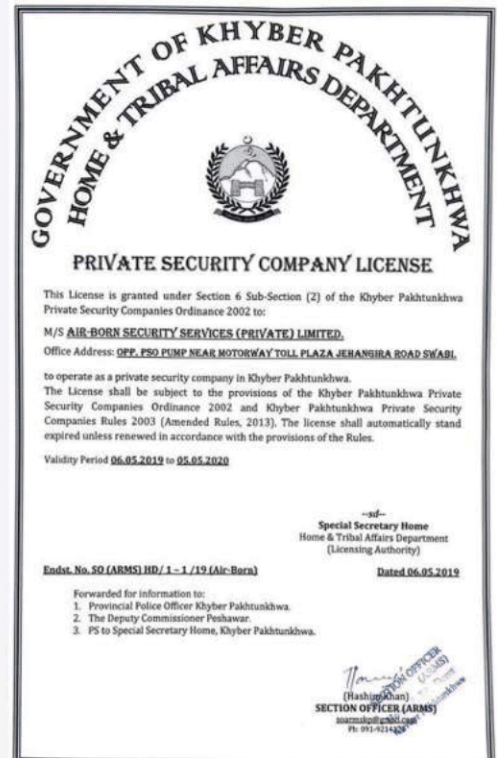

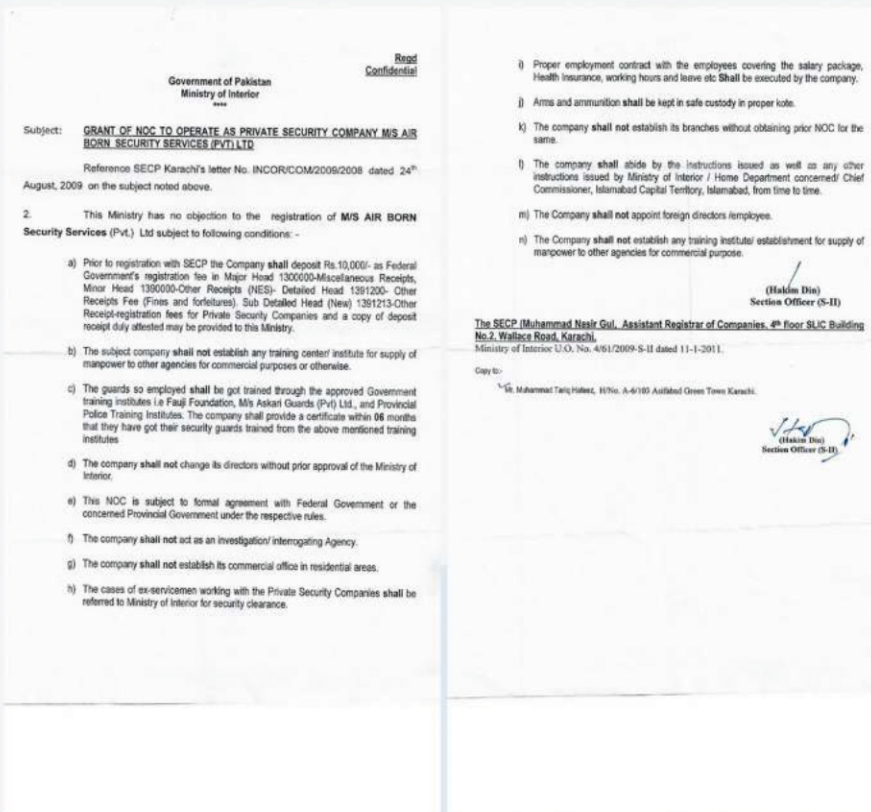

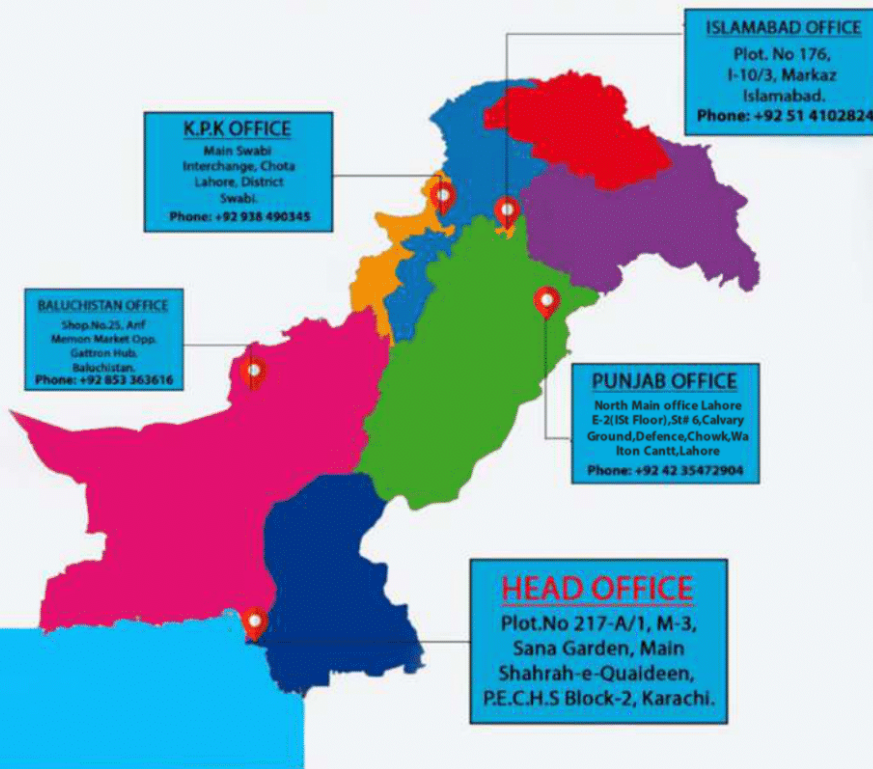
